

This First (1st) Amendment Agreement (the "Amendment Agreement") is made this 15th day of October 2021 between:

- (1) The Government of the Democratic Republic of Sao Tome E Principe, represented by the Executive Director of Agência Nacional do Petróleo or 'ANP-STP' (hereinafter 'The Government') on the one hand; and
- (2) PGS Exploration (UK) Limited, a company incorporated under the laws of England and Wales (registration number No. 2904391 whose office address is at 4 The Heights, Brooklands, Surrey, KT13 0NY, England) (hereinafter referred to as "PGS" which expression shall include its successors and permitted assigns) on the other hand.

(The Government and PGS being together the "Parties")

WHEREAS:

The Government and PGS are parties to a Brokerage Agreement dated 17th October 2013, BROKERAGE AGREEMENT, No.: E-AF-RS1302 DRSTP No.: AP-02, as amended from time to time (the "**Brokerage Agreement**"). The Brokerage Agreement was expressed to expire on the 17th of October 2021 and the Parties wish to record their agreement to extend the term of the Brokerage Agreement.

It is therefore agreed:

1. Interpretation

Capitalised terms in this Amendment Agreement (including in the Recitals) shall have the same meanings ascribed to them in the Brokerage Agreement, unless otherwise defined herein.

2. Extension of Term

The Term of the Amendment Agreement is extended to for a further period of sixty (60) days and the Amendment Agreement will expire on 17 December 2021.

3. Full force and Effect of Brokerage Agreement

The Brokerage Agreement, as amended by the Amendment Agreement, remains in full force and effect.
